## Terms & Conditions

### ELIGIBILITY

The #ThinkBlueWellesley contest is open to any resident of Wellesley, Massachusetts, aged 18 and up. Determination of whether a contestant meets these criteria shall be under the supervision of the Wellesley DPW whose decisions shall be final in all matters relating to this contest. Employees, contractors, town officials, members of town boards and commissions, and any other individual having a financial relationship of any kind with the Town of Wellesley or Water Words That Work, LLC are not eligible to win prizes. This competition is subject to all applicable federal, state and local laws and regulations. Void where prohibited by law.

### SPONSOR & VENDOR

The Sponsor of this contest is the Massachusetts Statewide Municipal Stormwater Coalition, or #ThinkBlueMassachusetts for short. The Wellesley DPW is participating as a member of this organization.

### TO ENTER

WELLESLEY residents can enter the contest by submitting one or more photos of one of the following subjects:

- **Storm Drains:** We want you to go “drainspotting” in your neighborhood or around the community. Take a picture of a manhole cover or storm drain and tag it on social media.
- **Walkin’ In the Rain:** Put on your raincoat, galoshes, and grab the umbrella and take a stroll in the rain. Check out where the water goes in your neighborhood. Take a picture of you and your family out on the walk and tag it on social media.
- **Smart Yard Care:** Taking your grass clippings to the local drop off site? Following the instructions on your lawn fertilizer bag? Take a picture and tag it on social media so we can reward your smart yard choices!
- **Scoop the Poop:** It’s always a good idea to pick up after your pet, and toss the waste in the trash. Take your best scoop the poop picture and tag it on social media.

Residents submit their photo by posting it to Instagram or Facebook with the hashtag #thinkblueWellesley and tagging the photo with @Wellesley.

### WINNING CRITERIA

Only one entry per mailing address will be accepted. Photos will be judged only for whether they clearly show one of the required subjects. Photos will not be judged on composition, lighting, or artistic merit.

## PRIZES

All Wellesley residents who enter the contest will be entered into a random sweepstakes drawing to receive one of 20 Amazon.com gift cards valued at \$100.

Winners will be notified by social media direct message, phone, or email on or about Friday, August 28th. The winners must provide a physical mailing address and email address to receive their prizes.
